Subject: Sacramento CoC Board Annual Membership Slate – ACTION

Background

The Governance Charter states the CoC Board will conduct a Public Call for Nominations for membership on the Sacramento CoC Board annually. The Call for Nominations for 2021 began in December 2020, for the appointment of new members and the renewal of terms for current members eligible for continuing service, with new terms commencing March 1 every year.

For 2021, the Call for Nominations opened at the December 8th CoC Board meeting. It was shared on the Sacramento Steps Forward (SSF) website and throughout the community via email. Declarations of Interest were accepted from December 14th to January 15th. Concurrently, current members with terms expiring February 28, 2021 that have not reached the three-term limit, were invited to continue to serve by submitting a renewal confirmation form. The Governance Committee, in its role as the annual

membership Nominating Committee, met January 20th to review applications and develop the proposed slate for approval. The proposed slate members' terms will commence on March 1, 2020 and are two years in duration.

Proposed Slate

In preparing the annual slate, the Nominating Committee had the option to appoint up to six new members without exceeding the 25-member cap specified in the Governance Charter: one vacancy carried over from the 2020 slate, two vacancies due to resignations in late 2020, one vacancy due to a member eligible for renewal resigning at the end of her current term on February 28th, and one vacancy due to a member reaching the three-term limit on February 28th.

A total of 36 new-member applications were received in response to the Call for Nominations, a record number of applications since the board was first convened. The Nominating Committee reviewed the applicants and selected six new members based on areas of expertise most needed on the CoC Board. Applicants not selected for membership will be encouraged to join committees and to participate in CoC Board meetings as guests/public attendees. The proposed slate below includes the six new members as well as 11 current CoC Board members with terms expiring at the end of February who confirmed their intent to renew. New members are listed in italics.

The 2019 CoC Governance Charter outlines a standard, formal membership structure for all committees. In order to comply with the charter, a formal recruitment process is being announced today to develop a slate for approval by the CoC Board in March 2021. The HMIS & Data Committee is the final standing committee to go through this process; with this action next month, all CoC Board committees will be in alignment with the Governance Charter.

Background

The CoC Board HMIS & Data Committee was formed in 2015 to address the HUD requirement that each CoC produce a Data Quality Plan and a Privacy & Security Plan. The committee drafts these plans in coordination with the HMIS Lead Agency (Sacramento Steps Forward). Every year, the plans are reviewed, revised as needed, and re-adopted by the CoC Board. The CoC Board appointed member Jameson Parker to co-chair the committee in 2020, in accordance with the Governance Charter. The committee co-chair is Erica Plumb. Historically, membership has been open to all interested parties, with no formal slate. Attendees are primarily representatives of agencies that use the HMIS for their homeless programs.

Recruitment for the HMIS & Data Committee is being announced at the CoC Board, followed by an application period ending February 26, 2021.
