Lisa Bates welcomed Beth Sandor from Community Solutions (CS) and described CS purpose, efforts, and goals. Lisa discussed partnerships and the interests to reduce COVID. Beth described different community efforts regarding homelessness. She discussed the creation of Built For Zero (BFZ), national level efforts, and the difficulties to solve homelessness as a systems problem. She shared a PPT and described the housing process system, data quality, hypothesis creation, system/team functions, feedback loop, system-level problem solving, monthly inflow/outflow, and other County's efforts. **Questions/Comments from the chat:** (1) Any specifics to

NON-CONGREGATE WEATHER RESPITE SHELTERING MOTEL VOUCHER EXPANSION

Sacramento Continuum of Care Board Meeting

January 13th, 2021

Department of Human Assistance Motel Sheltering

- Homeless shelters often run at capacity and the ability to provide immediate shelter is extremely limited
- Sacramento County Department of Human Assistance (DHA) utilizes local motels to offer emergency shelter for highly vulnerable unsheltered community members
- Motel vouchers are offered for a limited stay, often spanning three to seven days
- Intended to provide:
 - Respite through illness,
 - Recovery from a recent hospitalization,
 - ► A bridge when connecting to permanent housing

Motel Voucher Expansion for Weather Related Events

- In an effort to increase sheltering capacity over the winter months, the Continuum of Care (CoC) Board has approved up to \$600,000 of HHAP funding to expand non-congregate motel sheltering for unsheltered residents of Sacramento County
- Approximately 50 to 60 motel rooms would be utilized per night during weather related events (dependent upon motel capacity)
- The length of stay is intended to span the duration of the weather event and would be a minimum of three nights
- ► The following criteria would be used to trigger a weather related response
 - ▶ Nighttime lows of 37 degrees or lower for two or more days within a five day span; or
 - ▶ Rain for two or more consecutive days (forecast 60% or more); or
 - ▶ One day or night of rain combined with nighttime lows of 32 degrees or lower

Background

The CoC Board has convened a standing HMIS & Data Committee with informal/open membership for several years. In 2019, the board approved a revised Governance Charter that called for formalization of membership for all the standing committees. With the appointment of a formal HMIS & Data Committee slate this month, the CoC Board will complete the process of moving all of its committees into compliance with the formal membership requirements set forth in the 2019 Governance Charter.

HMIS & Data Committee Purpose and Scope

The HMIS & Data Committee (HDC) with assistance from the Homeless Management Information System (HMIS) Lead Agency, is responsible for carrying out responsibilities of the <u>Sacramento CoC Governance Charter</u> including:

- Ensuring HMIS is operated in compliance with HUD;
- Reviewing local reports to HUD to ensure accuracy;
- Ensuring accurate, timely and comprehensive data is available to inform Sacramento CoC activities;
- Reviewing and recommending changes to the Sacramento CoC Board on privacy, security, and data quality plans consistent with HUD regulations and notices;
- Developing and regularly reviewing HMIS policies and procedures materials; and

- Assisting in the evaluation of the HMIS Lead, as requested by the Sacramento CoC Board.

Member Roles and Responsibilities

The role of committee members is to represent their constituencies and the broader CoC community. The commitment to this committee is ongoing, with the expectation that members will serve an initial two-year term which can be renewed. There are no term limits on CoC Board committees. The HMIS & Data Committee meets quarterly, at 10 AM on the second Thursday of January, April, July, and October and meetings are currently held via zoom. Member responsibilities include reviewing materials prior to meetings, attending meetings, advising staff in advance if a meeting will be missed, and following up on any additional commitments the member makes over the course of the committee's work.
