

Definitions

Homeless unaccompanied youth under 25 years of age, or families with children and youth who do not qualify under #1, #4 and #5 living situations, are considered homeless, if they:

- 1. Lack a fixed, regular, and adequate nighttime residence, including any of the following (refer to Notice PIH 2021-15, section 8(a)(3)):
 - a. Sharing the housing of other persons due to loss of housing, economic hardship, or a similar reason; living in motels, hotels, trailer parks, or camping grounds due to the lack of alternative adequate accommodations; living in emergency or transitional shelters; or are abandoned in hospitals; or other place not meant for human habitation, including cars, parks, abandoned buildings, substandard housing, bus or train stations, or similar settings (as defined under the McKinney-Vento Homeless Assistance Act (42 U.S.C. 11434a));
 - b. For whom it is not possible to live in a safe environment with a relative and who has no other safe alternative living arrangement; (as defined under section 387 of the Runaway and Homeless Youth Act (42 U.S.C. 5732a);
 - c. Is awaiting foster care placement (as defined under section 41403 of the Violence Against Women Act of 1994 (42 U.S.C. 14043e-2);
 - d. Who has a primary nighttime residence that is an institution that provides a temporary residence for individuals intended to be institutionalized (as defined under section 3 of the Food and Nutrition Act of 2008 (7 U.S.C. 2012));
- 2. Do not have a lease, ownership interest, or occupancy agreement in permanent housing at any time during the last 60 days immediately preceding the date of application for homeless assistance;
- 3. Two moves or more during the 60-day period immediately preceding the date of applying for homeless assistance; and
- 4. Can be expected to continue in such status for an extended period of time because of chronic disabilities; chronic physical health or mental health conditions; substance addiction; histories of domestic violence or childhood abuse (including neglect); the presence of a child or youth with a disability; or two or more barriers to employment, which include the lack of a high school degree or General Education Development (GED), illiteracy, low English proficiency, a history of incarceration or detention for criminal activity, and a history of unstable employment.

Chronically homeless:

Living outdoors or other place not meant for human habitation (i.e. car, park, abandoned building, bus or train station, airport, or camping ground), emergency shelter or safe haven continuously for at least the last 12 months or on 4 separate occasions in the last 3 years, totaling at least 12 months; and has a disability, as defined by the HEARTH Act as:

- 1. Long continuing or indefinite, substantially impedes the individual's ability to live independently and could be improved with suitable housing, **and** is
- 2. A diagnosable substance use disorder, serious mental illness, developmental disability, post-traumatic stress disorder, cognitive impairments resulting from a brain injury, HIV/AIDS, or chronic physical illness or disability, including the co-occurrence of 2 or more of those conditions.
