## **Volunteer Recruitment & Activities**

- Recruitment (1000 volunteers)
  - Target groups
    - Former PIT volunteers
    - New interested volunteers (e.g., students, families, general public)
    - SSF community partners & volunteer network
    - SSF staff + PITC members
    - Personal connections
  - Post-recruitment
    - Complete registration with contact information
    - Complete volunteer waivers (health, liability forms)

### Proposed Activities

- Deployment site set up & take down
- Deployment site greeters/runners & management
- Group & equipment sign in/out processing
- First Aid & general health check station
- Hygiene/incentive kit assembly & distribution
- Count supplies/packets assembly
- Community canvassing/support
- Count mapping trial run



## **Volunteer Training**

- Roles
  - 1 Lead
  - 1 Counter
  - 2 Recorders/Runners/Supports
  - Cross-train on roles to ensure ample coverage of duties
- Training Content
  - Roles & responsibilities overview
  - General safety & COVID-19
  - Survey instrument/technology/application
  - o Homelessness 101
- Training Offerings
  - Produce & publish on 2022 PIT webpage
  - Offer office hours to answer volunteer questions live



## **Events Planning & COVID-19 Considerations**

- Ensure event participant safety, including COVID-19 mitigation protocols
  - COVID-19 vaccination accountability
  - General health check
    - Cold, flu, & viral symptom check
    - Temperature check
- Review event budget
  - Purchase/rent required supplies and spaces
  - Hire event planning support staff
- Confirm event dates
  - Update and circulate event materials
