#### **HUD Guidance**

- > 2021 PIT count will not be comparable to other PIT counts
- In doing a 2021 unsheltered PIT, HUD wants to (1) know how the unsheltered PIT count has been impacted by COVID-19; and (2) be able to say if homelessness increased or decreased in different types of communities (+ / - only)
- CoCs should reduce or eliminate the reliance on volunteers
- Set of exemptions & alternatives detailed in HUD guidance



#### 2019 Unsheltered PIT Count

- Nearly 1,000 Volunteers
- ➤ Held Over 2 Nights
- 2 Large Volunteer Deployment Sites (on both nights)
- Spontaneous Assembly of 3-4-Member Count Teams
- 171 Canvassing Sites Visited
- 550 In-Person Interviews Conducted



### 2021 Unsheltered PIT Count- Local Options

- ➤ Full Count
- No Count
- Observation-Only Count (1-2 days)\*
- Very Brief Survey Count (up to 14 days)\*
- Alternative Data Source with Enhancements



<sup>\*</sup> No demographic survey required by HUD this cycle

# Preliminary Recommendation: Alternative Data Source with Enhancements

- Use the "By Name List" (BNL) generated out of HMIS
- Cross-reference BNL with very brief surveys of unsheltered persons to determine overlap (# TBD)
- W/buy-in from funders & providers, multi-agency collaborative of outreach workers to conduct surveys over 10-14 days
  - Each survey can be completed in less than 2 minutes
  - 200-400 surveys are likely needed, still working to set the number

# Additions to Recommendation of Alternative Data Source with Enhancements to Consider

- In addition to pursuing the Alternative Data Source with Enhancements approach, the CoC could:
  - Request a total exemption from counting but proceed with this approach, as a safeguard in case things go awry and the data collected is not reliable
  - Announce plan to do, or explore doing, a 2022
     Unsheltered PIT as part of the recommendation
