Sacramento YHDP Planning Team Notes

March, 15th 2023 3-4:30

MEETING MINUTES

The Powerpoint was shared with the group.

All projects were reviewed, and the group provided feedback on what was missing. They shared the following:

- App case managers could go on and see who is looking for specific services and reach out to folx. So creating a push and pull option in the app, similar to a CE system push and pull.
- Diversion could be short-term but could be available for up to a year.
- Master leasing units available in housing programs.
- Housing programs will have individualized case management plans.
- Peer navigator working with YYA as folx transition from high school or GED to higher ed and/or trade schools. And/or someone who can navigate school in general to dorms/funding for housing/education, etc.
- AOD services will be provided as a service in all programs. YAB asked if it could be a standalone program. That is something that HUD may consider, and Piper stated that she could reach out to HUD. Same question was asked about MH and employment services. Piper shared that employment services are more often funded then AOD and MH. Bridget asked if a TH program with an AOD focus was something that could be funded though YHDP. The group also asked if an AOD counselor could be on staff in a housing program, creating a one-stop shop.
- Housing services are centered on harm reduction and supportive care are emphasized. Both housing and supportive services are necessary.
- Education services expanded to include technology needed, etc. Also, assistance with FAFSA.

The YAB would like an RFP to go out that includes the top three projects vs all of the projects that were presented. The YAB voted and the following votes were recorded:

- 1. Diversion 1
- 2. TH 2
- 3. RRH 6
- 4. PSH 0
- 5. Drop-in center 2 either new if serving an underserved location or expansion of current drop-in centers.

The group asked why YAB leaned more into RRH vs TH. YAB shared the following:

- They wanted a focus on long term care and felt like TH may exacerbate someone's experience with homelessness.
- Wanted to focus on getting people off of the streets.
- Length of time was tied with independent living and having support in phasing out of programs. Normally TH is not as independent and folx felt like it lacked transition and support to independent living.

The meeting moved to goals/objectives/action steps. The group reviewed sample goals, and then went into breakout rooms.

Housing goals:

- 1. A program that has a clear exit for folx who age out. A secure and warm handoff is part of all programs.
- 2. In the event that programs do not succeed, the program states what the exit will be for YYA and staff.
- 3. A lot of vouchers in Sacramento, but there are not processes in place for it to move quickly for YYA. Creating a more youth-friendly process. Also, creating better relationships between housing and housing authorities.
- 4. Many of the YYA feel that staff are under equipped to handle certain situations. They want all staff are trained in harm reduction and sensitivity training.
 - a. Creating positions for YYA to oversee that training.
 - b. Creating a CQI process that would assess how YYA feel in programs.
 - c. Also, creating a certification process for agencies.
- 5. AOD services being in all programs.
- 6. Programs having initial efforts to get YYA engaged in the community. PYD.
- 7. Expand outside of the downtown area, so programs being more far reaching.
- 8. YYA want to be involved in the implementation of funded programs, including interview processes.
