County of Sacramento: Emily shared updates that the Board approved a Safe Parking program and will likely open early next year. Also, another approval from the Board was made on the Safestays partnership with the State and City of Sacramento on a WellSpace site. Additional updates will be shared in upcoming meetings.

City of Sacramento: Brian mentioned the City's efforts, as Emily shared previously, on the WellSpace site and a Safeground location is opening up (anticipated in the beginning January 2024). Additional details will be shared after the official release.

SHRA: Troy shared no new updates at this time.

MCPs: Garrick Wong shared details about the DCFS Incentive Program, HHIP measurement period concluded on October 31, and now working with partners to aggregate data to submit to DCHS. We are awaiting details on the re-investment funding option which is an opportunity to earn back 100% of funds not earned through the program. All plans in Sacramento remain committed. Managed Care Plans continue to meet with SSF regarding HMIS, access, assessments, and now working on bi-directional data sharing with HMIS regarding managed care plans.

Stefan shared that the System Performance Committee (SPC) approved the Community-Wide Standards at their December 6th meeting. Ayanna shared we are now seeking the CoC Board's approval. She mentioned this work is inclusive of efforts from the SPC, SHRA, City, SSF, and County. After extensive public comment, review, and revision, this is now ready as version 1 to be adopted by the CoC, City, and County. HUD requires establishing standards for services. The document points to where there are regulations that apply. They are inclusive of these requirements, but also more comprehensive and, in some parts, aspirational. We understand programs may not be able to achieve these standards right away and may take years of restructuring, funds allocations, and other work to meet these standards while these standards act as a guiding light. We also recognize there are other funding streams, and flexibility around accommodating multiple requirements in these cases has been built in. We welcome all entities in the housing space to look to these standards. Questions and comments were made. Please see the recording for more details.

B. Regional Coordinated Homeless Action		8:55 AM (20 minutes)	Informational
Plan (RCHAP) Public Engagement Process			

Joel shared details on the RCHAP planning process and context. We are continuing the All In branding to communicate continuity. We are building from the LHAP to the RCHAP. Additional context was provided that Homelessness has grown rapidly over last PIT Counts. We are sheltering more and more people, but the unsheltered count is also growing alongside the rest of California and exceeding state averages. Correlating factors include almost exclusively rental vacancy rates and housing prices, which have increased dramatically, which is in line. To counteract the trend, we have taken actions including the LHAP and the 6 strategies, extended by the housing plan, and informed by gaps analysis. We are working to make homelessness rare, brief, and nonrecurring. See the recording for details on the extensive goals achieved. This has led to system-wide effects, increasing positive exits to housing, though more work is still needed. To improve, we will take several strategic steps detailed in the recording. We ask the CoC Board to spread the word and adopt the MOU when the time comes. For more information, please see the recording.
