- YAB approved the public CCP quarterly report format
 - Note that the goals outlined on the Quarterly Report are only those identified as Year 1 priority for 2024. Sacramento's CCP outlines additional goals for subsequent years.
- YAB and CoC Board approved 17% (\$2,268,818) from the CoC HHAP-5 allocation on:
 - Continue youth sheltering: \$1,334,599
 - Youth prevention: \$534,000
 - YAB Supports: \$400,000
- The YAB provided feedback on the Regionally Coordinated Homelessness Action Plan (RCHAP), adopted in March 2024.
- Objectives are on track to be completed: 6/11
