# VI. System Performance Measures (SPM) Overview SSF Data & Analytics Director Trent Simmons, SSF Data & (15 minutes)

Trent shared a <u>presentation</u> on FY 2023 HUD SPMs. The information can also be found on the SSF website under data. The goal of the SPM is for HUD to measure homelessness across the US and there are 7 key indicators that HUD uses. Trent went over:

- **Measure 1:** Length of time persons remain homeless (LOTH)
- Measure 2: % of persons who returns to homelessness within 2 years of becoming housed
- Measure 3: Annual counts of sheltered persons in HMIS
- **Measure 4:** Employment and income growth
- Measure 5: Number of persons who become homeless for the first time
- Measure 6: Not analyzed in Sacramento
- Measure 7: Successful placement in permanent housing

Priorities operationalized through competition policies and the points awarded for certain criteria in the scoring tool.

Adding Community Standards requirements.

Prioritization by Project Type & Prioritization by Population/Subpopulation/Household Type Served

Based on recent gaps analysis updates and consistent with the recently adopted regionally coordinated homeless action plan, <u>All In Sacramento</u>, the Sacramento Continuum of Care has identified a need for additional permanent supportive housing (PSH) and rapid rehousing (RRH) capacity to address current needs and improve system performance. To address these needs, the following priorities have been established for new projects and reallocated CoC program funding:

- PSH for chronically homeless families and individuals, with priority for projects targeting under-served populations, including seniors and people greater vulnerabilities (consistent with CAS Extremely Vulnerable Household (EVH) criteria).
- PSH scattered site projects that leverage existing scattered site PSH relationships and service model with higher performing renewal agencies (with definition for "high performing" projects, as defined in the Review and Ranking section, above.

 RRH for homeless individuals and families, including unaccompanied youth, coming directly from the streets or emergency <u>shelter</u> or fleeing domestic violence, with priority for those who do not qualify for other federal, state or locally funded rapid rehousing assistance.
