Permanent Supportive Housing Goals

- End experience of homelessness, gain housing
- Support participants in maintaining least restrictive community-based housing
- Reduce acute psychiatric hospitalizations
- Reduce incarceration
- Improve health by increasing access to primary care
- Support engagement in meaningful employment/activities and social connectedness

Permanent Supportive Housing Basics

<u>Housing</u>

- For people experiencing homelessness who have a disability that impacts housing stability
- No time limits
- Participant holds lease, and has tenant rights and responsibilities
- Income-based contributions
- Site-based or scattered site

<u>Services</u>

- ✤Required to be available
- Voluntary participation
- Housing First approach
- Ratio of services based on participant need
- Provision or linkage to mental health and/or substance use services, if desired

Referring to BHS PSH

Client must be linked to a Full Service Partnership (FSP)

• If CORE client continues to be homeless or can't self sustain after 6-9 months, consider a clinical consult on whether a <u>Level of Intensity Screening Tool (LIST)</u> should be completed

Client must be in HMIS

- Completed VI-SPDAT
- Completed Case Conferencing Tool

Get your client housing doc ready

- Most common forms are available at Documents Sacramento Steps Forward
- If FSP has access to BHS built units, they will work with property management to make referral
- If FSP does not have access to a BHS built unit, attend population specific case conferencing meetings

PSH Investments

\$75 million invested in **Mental Health Services** Act (MHSA) and No Place Like Home (NPLH) funding to build and/or renovate apartments for behavioral health clients experiencing or at-risk of homelessness

Portfolio

- Dedicated apartments for children, youth, adults, and older adults
- 401 dedicated apartments across 16 properties
- 175 new apartments across 7 properties in 2024-2026
- 85 apartments will be added through natural turnover (vacancies)
- 661 total apartments dedicated to BHS clients
- PSH services are provided by Full Service Partnership (FSP) programs

What is PSH?

In Our County

Since 2007, Sacramento County Department of Health Services, Behavioral Health Services (BHS) Division, has invested over \$75 million in Mental Health Services Act (MHSA) and No Place Like Home (NPLH) funding to build and/or renovate apartments for behavioral health clients experiencing or at-risk of homelessness. BHS has developed a portfolio of site based PSH units reserved for individuals and families eligible for MHSA Full Service Partnership (FSP) services.

PSH Services

REV. 7/2024

BHS has twelve contracted FSP programs. FSPs provide the full spectrum of high intensity outpatient mental health treatment for individual and families living with serious mental illness. Tenants of MHSA units receive behavioral health services and intensive case management through FSP programs. FSP Providers servicing PSH units include: Capital Star Community Services, El Hogar Community Services, HeartLand Child & Family Services, Hope Cooperative, Telecare, and Turning Point Community Programs.




Behavioral Health Bridge Housing (BHBH)

UPDATE: SUMMER 2024

What Is Bridge Housing and Who Qualifies?

Short- and mid-term sheltering options to get people off the streets and serves as a "bridge" to permanent housing.

- Unsheltered homeless with serious mental illness (SMI) and/or substance use disorder (SUD)
- Clients must qualify to be linked to a BHS contracted program
- Prioritizes CARE Court participants



BHBH Funding Round 1

\$43M Round 1 grant award through fiscal year 26/27.

- Grant dollars are split and requires ability to accept first client by January 26, 2025
 - 25% for infrastructure ends January 26, 2025
 - 75% for ongoing bridge housing operations.
- Projects:
 - 100 beds Safe Stay \$10,250,000
 - Approximately 120-135 beds for special populations LOI \$26,400,000
 - Other* allocated Funding \$6,427,000

(*Other allocation includes administrative costs, outreach and engagement, repour building materials, rental assistance, motel vouchers and operations).

BHBH Funding Round 3

\$15M award announced July 25, 2024 - Round 3 grant award through fiscal year 26/27.

- Awaiting Board of Supervisors' approval
- \$5,00,000 for infrastructure
- \$10,000,000 for ongoing bridge housing operations.
- Goal:
 - 50-65 additional beds across Sacramento County.



What Will BHS Bridge Housing Look Like?*

*In Development and subject to change dependent on real estate options at the time of program roll out.

235* Behavioral Health Bridge Housing beds

- 100 interim housing beds across 3 Safe Stay communities
- Develop, purchase, renovate property for at least another 135 beds
 - 30 for sober living
 - 105 for special populations that are over-represented and under-served in the homelessness population
- Flexible funding to support "barrier busting" activities such as credit clean up, expungement services, etc.
- Housing navigation and rental assistance funds if clients drop out of BHS services but remain in the BHBH bed.

Safe Stay Communities

Using BHBH funding and administered by the Department Homeless Services and Housing (DHSH), sites will be operated by City Net and First Steps. The sites will include:

- On site shower and restroom facilities, serviced by 3rd party vendors
- On site offices for operations staff, to include private rooms for case management and common room for multidisciplinary team meetings
- Fencing with privacy shading, security offices will be located at access gate, and will control cars and pedestrian access to the site
- A large, shaded common area for community gathering, meals, and pet relief area
- Common area for dining & recreational use









Program Design

- In kind voluntary BHS services for SMI and SUD and coordination of care with Sacramento County Behavioral Health
- Coordination with local homeless Continuum of Care, cities and other homeless service efforts within the County
- Referred by Homeless Engagement and Response Team (HEART)
- Low Barrier Shelter
- On site voluntary support services
- Serves singles and couples
- Best practices for BHBH consist of:
 - Housing First approach
 - Harm reduction strategies
 - Trauma-informed care
 - System collaboration

BHBH Phased Approach

Phase 1 – Stabilization

Phase 2 – Housing Readiness

Phase 3 – Intensive Housing Navigation

Graduation – Stable and Housed

BHS Intensive Services and Supports linkage will support clients through to permanent housing solutions by providing treatment and housing navigation.



Eligible Population

Prioritized for

- CARE Act participants and/or
- Prioritization for special populations of homelessness: Justice Involved, Elderly 55+, Former Foster Youth, Black/AA, Fleeing DV, and LGBTQ

Must also...

- Be literally homeless and unsheltered
- Be eligible for BHS specialty mental health services
- Be unlinked at time of screening and referral
- Be able to take care of ADLs

Referrals to BHBH

Who can make referrals?

- Homeless Engagement and Response Team (HEART) clinicians and peers who work in homeless encampments who can also work in partnership with other outreach and engagement teams
- CARE Court for clients who are considered literally homeless
- Sacramento County Department of Homeless Services and Housing (DHSH)
- Providers for special populations as part of their program design, Mental Health programs, hospitals, and community partner cans also refer to HEART for a screening tool. HEART will determine if referral is appropriate.









How BHS providers support clients in BHBH

Attend and participate in case conferencing meetings

Support client's housing and exit plan

Collaborate with BHBH shelter provider

MHP providers supporting BHBH clients

Provide behavioral health supports on site, in office or community

Obtain appropriate releases

Leverage flex funding, can be utilized for the following:

- Voucher Supplement
- Rent Gap
- Master Lease
- Short Term Hotel/Motel Payment
- Security Deposits
- Utility payments or arrearages
- Credit repair fees
- Moving expenses/furniture/other household goods

Additional BHS provider supports

Services will be important to support clients through to permanent housing solutions.

- Provide focused mental health treatment and address any behaviors that may present as a barrier to housing and/or behaviors putting their placement at the Safe Stay sites at-risk
- Build coping skills
- FSPs to provide 24/7 response that includes de-escalation
- COREs develop after hours crisis response plan
- Support housing navigation and sustainable housing
- Support sustainable community-based stabilization and integration
- Utilize the SSI/SSDI Outreach, Access, and Recovery (SOAR)' program model to increase access to Social Security disability benefits for people experiencing or at risk of homelessness
