David shared previous amendment recommendations for the HMIS Privacy & Security Plan, including specific details that recommendation #1 and #2 are applied/in compliant, however recommendation #3 we are not currently

applying/in compliant. In 2025, the SSF HMIS & Data Team plans to do a full review and edit on this plan and the HMIS Data Quality plan. Questions were asked. Please see the recording for details.

#	Recommendation
1	Per the Privacy and Security Monitoring – Recommendation 1: scaling back the frequency of audits to an annual security audit as outlined in the plan by each Agency and audits on an as-needed basis by the Lead Security Personnel.
2	In the current Plan, the procedures are outlined in the 'Reporting Security Incidents'. The intention of the Data Breach Policy and Procedures is to strengthen the language and provide clarity. Recommendation 2: The inclusion of Appendix A: Data Breach Policy and Procedures.
3	Should recommendation #2 be approved, then designated members of the HDC will be part of the process of approving the suspension of an HMIS end user, as well as reactivating or reinstating HMIS access. Recommendation #3: We are asking for 3 HDC members to volunteer to be part of the review and approval process of approving the suspension of an HMIS end user, as well as reactivating or reinstating HMIS access. The designated members will be contacted on an as-needed basis. The HMIS System Administrators will convene a meeting to discuss and review the suspected instances of noncompliance and/or security violations that HMIS system security and/or client privacy has been compromised.

Rachel shared an update on the FY24-25 CoC Program NOFO that included finishing a recommended priority listing developed by the review panel that was then approved by the CoC Board on Wednesday, October, 9. We have one new project in Tier 1 and a few renewal projects in Tier 2. SHRA has a straddle project that is split between Tier 1 and Tier 2. Please see the supporting materials for a detailed priority listing. The national competition will wrap up by October 30th. This includes answering questions, completing e-snaps, and making attachments. The full application will be posted on our website at least 2 days before October 30th.

CoCBuilds NOFO is happening at the same time as the CoC Program NOFO. These funds will likely be one time and are dedicated to the construction, acquisition, and rehabilitation of PSH units. There are 3 final local applications and SSF will send 1 to HUD and the national competition. The due date to HUD is Nov 21st. Questions were asked. Please see the recording for more details.
